


**TRUST DEED OF ANSHITA FOUNDATION**  
(Instrument of Trust)

This Deed of Trust executed on this 9<sup>TH</sup> October of 2018 between Mr. Alok Mishra son of Shri Dinesh Chandra Mishra resident of Village- Saraimandraj, Post- Bhawarnath, Tehsil- Sadar, Pargana-Nizamabad, Distt- Azamgarh- 276001, hereinafter called the 'Settlor' (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives) of the one part,

AND

Shri Harishchandra Mishra S/o Ramanand Mishra R/o Village- Saraimandraj, Post- Bhawarnath , Tehsil-Sadar, Distt-Azamgarh-276001 hereinafter jointly referred to as 'trustees' (which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustee or trustees for the time being) of the other part.


Whereas the Settlor is desirous of establishing a trust for public charitable objects and whereas the trustees have, at the request of the settlor, agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents.

Now this indenture witnessed as follows;

1. That, in order to effectuate his aforesaid desire, the settlor has set apart and handed over to the trustees, a sum of Rs. 5,000(Five thousand) (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the name of the trust shall be ANSHITA Foundation and its office shall, for the present, be situate at Village-Saraimandraj, Post- Bhawarnath ,Tehsil-Sadar,Pargana-Nizamabad,Distt-Azamgarh-276001 and/or at such other place or places as the trustees may decide from time to time.
3. That the objects for which this trust is established are:
  - (a) To import, spread and promote education and learning including primary ,higher and college education(Technical ,non-technical Agricultural,Engineering,Medical,Commerical ,Scientific or any other subject among boys and girls in schools,colleges or other institutions and establish and found instiutions for imparting such education.
  - (b) To establish ,found ,support and/or to maintain educational and other institutions such as pathshalas,schools,college,universitiesliabraries,publichalls,hostels,boarding houses for students .
  - (c) To apply the Trust Fund or any part thereof for the general purposes of designing, constructing, establishing, running and maintaining of schools and in payment of all rents, rates, taxes, cost of insurance, repairs and other outgoings payable from time to time in respect of the schools or any property on which schools are constructed.

- (d) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- (e) To design, construct, establish, run and maintain boarding houses, libraries, sports fields and stadiums, physical and cultural activity centers etc. for the persons who study at the schools established by the Trust.
- (f) To enter into franchise arrangements/agreements with educational boards, corporations, individuals or any other persons who may wish to run the schools constructed by the Trust.
- (g) To establish, develop, maintain and grant aid in cash or in kind to hospitals, medical schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centres and/or such other similar charitable institutions in India for the benefit and use of the general public.
- (h) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.

- (i) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- (j) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses, for use by public in general.
- (k) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- (l) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- (m) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- (n) To construct repair and manage the marghats, cemeteries and burial grounds.
- (o) To grant aid or render assistance to other public charitable trusts or institutions.

- (p) To promote and advocate Human Rights and Fundamental Freedom for all without any discrimination of race, religion, caste, color, sex and language.
- (q) To develop and mobilize Community and Natural Resources to give the right direction to people of the marginalized and economically weaker section of the trust for their sustainable overall development.
- (r) To organize and take up Health, Educational and Welfare programmes for needy Women and children on priority basis.
- (s) To conduct research studies on the social and economic conditions of people with a view to involving ways and means for their development within their social historical framework and to seek promotion of rural development such as provision of drinking water, rural industrialization as well as Public Convenience for people.
- (t) To encourage and promote family welfare activities among needy people.
- (u) To start and assist the relief measures in those parts of the country which become affected by natural calamities like famine, fire, flood, earthquakes etc.
- (v) To acquire, purchase or otherwise own or under take on loan or lease or hire temporarily or permanently and movable or immovable property necessary or convenient for the furtherance of the objects of the trust.
- (w) To organize and take-up Health, Educational and Welfare programmes for needy & poor Women & Children.

- (y) To promote traditional therapies like Yoga, Naturopathy, Meditation, Acupressure, Acupuncture, Massage Therapy, Ayurveda, Homeopathy, Reiki etc.
  - (z) To establish, build or manage Hostels, Short Stay Homes, Rehabilitation Centers, Shelters, Crèches, Child Care Centre or Children's Home, Counseling Centers and Help Line Centers for Women, Children, Old aged persons, Drug addicts and needy persons.
4. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time totime.
  5. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3hereinabove.
  6. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of thetrust.
  7. That for the furtherance of the objects of the trust, the trustees shall have the following powers:
    - (a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or withoutconditions.
    - (b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time totime.



- (c) To convert and deal with the trust property and/or any investments for the time being.
- (d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.
- (e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- (f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (h) To open account in the name of the Trust, Trustees and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- (j) To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- (k) To appoint or make provision for the appointment of any person (including all or any of



the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.

- (l) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (m) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (n) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.
- (o) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- (p) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India

- which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, Organization or Trustees to start maintain, or carry out such charitable objects.
- (6) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (8) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- (i) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorised to amalgamate.
- (ii) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organisation on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred. terms and conditions as they may in their absolute discretion think fit.

- (v) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- (w) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
- (x) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- (y) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

**Initial Provision:**

(i) From the date of registration of this trust the author of this trust deed shall be Mr. Alok Kumar Mishra who is also founder of this trust. Further Alok Kumar Mishra will also be Managing trustee of this trust R/o Village-Saraimandraj, Post-Bhawarnath, Tehsil-Sadar, Distt-Azamgarh-276001. Present Managing trustee can transfer his all responsibilities to any other trustee at his sole discretion .

(ii) Any person who is desirous of being trustee in the above trust can become trustee after

paying an amount of Rs 5000/- (Five Thousand) through an account payee cheque/draft and further permission of managing trustee is also required to become trustee. If due to any reason applicant can not become trustee then the applicant amount shall be refunded.

(iii) The managing trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on -such terms as to retirement and re-appointment as the trustees for the time being considered proper. A person shall cease to be a Trustee either:

- (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or
- (ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees.

9. **Transfer of the Managing trustee post:** Managing trustee can provide/transfer his own post to one of the trustee during his life span.

Any person who becomes managing trustee in above situation will have all the right of managing trustee. In the absence of any other provision registered with registrar, on the event of death of Mr. Alok Kumar Mishra will be managing trustee of this trust. Should the managing trustee/President of the successor of managing trustee his succession to express in writing to give his signature.

10. **Board of trustee:**

(i) The number of the Trustees shall not be less than two and more than seven. If the number of the trustees shall fall below two, the Trustees shall not, except for the purposes


